Passengers:

Passengers need to call at least an hour ahead of their appointment time for in town service. We will strive to get you to your appointment on time. A 15 minute wait may be common. Appointments will not be made after 3:30 for same day trips. Passengers who must use the lift will not be taken on days when the wind is blowing 40 mph or more for the safety of the passenger and the driver. Passengers who are in wheelchairs will be asked (not required) to bring a personal caregiver to go along on the trip (the caregiver is not charged). Passengers are expected to be ready at their appointment time. The driver is not expected to go into the home, assisted living facility, hospital, etc. to locate the passenger.

Fares:

The cost for all riders is:

\$1.25 round trip per person in Perkins County

Trips to Ogallala, Imperial and North Platte are scheduled as needed. Fares vary depending on distance.

Public Transportation is available to anyone in Perkins County on a first come first serve basis.

Passengers may pay daily for rides or purchase a pre-paid transit pass from a Public Transit staff member.

Bus Guidelines:

Occasionally, Public Transit staff and riders are faced with situations in which one rider is disruptive and it has a negative impact on all those around them. To protect the rights of all riders to enjoy and access service of the Public Transit Bus, the bus driver and the County Commissioners will have the authority to deny service to persons for the following reasons:

- 1. Individuals using abusive language.
- Individuals who consistently have body waste problems, or other offensive odors.
- 3. Individuals who are under the influence of alcohol or drugs.
- Individuals who make Sexual Advances/ Harassment to other passengers or driver.
- 5. Individuals who make threats or show weapons.
- 6. Individuals who refuse to pay fares.
- 7. Individuals who refuse to have mobility device secured.

Public Transit personnel are required to document any problems that may require refusal of service. A written warning will be forwarded to the individual, explaining the problem and possible denial of service if the problem continues.

Transporting Children

All children are required to use a seat belt or a federally approved restraint system. Children under the age of 6 must be accompanied by an adult with the exception of students riding to and from Perkins County Public school.

Information pertinent to the child, such as parent and caregiver address and phone numbers, pickup and drop off locations will be given to



the bus office. Parents will be required to read and sign the student rider policy prior to their child riding.
