The regular meeting of the Board of Commissioners of Perkins County, Nebraska, was held at 8:30 a.m. in the County Courthouse in Grant, Nebraska.

Present: Commissioners Steve Tucker, Darin Robertson, Mark Bottom, Attorney Richard Roberts, and Clerk James Brueggeman.

Commissioners reviewed the 2024 Perkins County Noxious Weed Control Act report prepared by the State of Nebraska. Commissioner Robertson made a motion to have Chairman Tucker sign the summary letter. Seconded by Commissioner Bottom, roll call vote, 3 ayes, motion carried.

Business With Officials:

The Board heard reports from Sheriff Jeffrey Miller, EMT-A Travis Ogg, Highway/Noxious Weed Superintendent Steve Leimer, and County Clerk James Brueggeman concerning their respective areas of county operations. Julie Sestak attending the meeting at request of the Commissioners and agreed to serve as a member of the Perkins County Personnel Handbook Committee with Chairman Tucker and Clerk Brueggeman.
