Unfinished Business:

Commissioners discussed the Perkins County Veterans Service Officer vacancy. Commissioners directed the Perkins County Clerk's Office to advertise the vacancy on the county website and in the newspaper.

New Business:

A delegation of Perkins County Fair Board members met with Commissioners to discuss ongoing and potential improvement projects at the Perkins County Fairgrounds. Kasey Kroeker presented information on the status and costs of the following projects: new 4-H Show Barn, potential water drainage solutions, and upgrades to the 4-H Exhibit Hall.

Commissioners discussed and reviewed the proposed Perkins County and iWorQ Service Agreement for the Perkins County Roads Department. Commissioner Bottom made a motion to have Chairman Tucker sign the agreement. Seconded by Commissioner Robertson, roll call vote, 3 ayes, motion carried.

Commissioners discussed and reviewed the Perkins County Noxious Weed Control Notice Resolution. Commissioner Robertson moved to approve Resolution 2025-6

Perkins County Noxious Weed Control. Commissioner Bottom seconded, 3 ayes, motion carried.

Commissioners discussed the bid proposal received for Elsie/Paxton Road Repair. Commissioner Bottom made a motion to approve the bid proposal from Shelco Asphalt & Paving in the amount of \$19,960. Seconded by Commissioner Robertson, roll call vote, 3 ayes, motion carried.

Commissioner Bottom made a motion to appoint Nick Turner to represent District 2 on the Perkins County Health Services Foundation Board. Commissioner Robertson seconded the motion, roll call vote, 3 ayes, motion carried.

Commissioners discussed the bid proposal from Kidwell regarding placement of security cameras at county facilities. Commissioner Robertson moved to accept the proposal from Kidwell with removal of some of the quoted cameras from the plan. Commissioner Bottom seconded, roll call vote, 3 ayes, motion carried.

Commissioner Bottom moved to adopt Resolution 2025-7 Temporary Use of a State Highway System for Special County Event (Perkins County Fair Parade) and have Chairman Tucker sign. Seconded by Commissioner Robertson, roll call vote, 3 ayes, motion carried.

Commissioners and Perkins County Clerk James Brueggeman serving as Ex-Officio Clerk of the District Court discussed the proposed agreement between the Nebraska Administrative Office of the Courts and Probation and Perkins County transferring Ex-Officio duties of the Clerk of the District Court to the Clerk Magistrate of the Perkins County Court. Commissioner Bottom made a motion to have Chairman Tucker sign the agreement. Commissioner Robertson seconded the motion, roll call vote, 3 ayes, motion carried.

Business With Officials:

The Board heard reports from Sheriff Jeffrey Miller, EMT-A Travis Ogg, Highway/Noxious Weed Superintendent Steve Leimer, and County Clerk James Brueggeman concerning their respective areas of county operations. The Board acknowledged as received fee reports for January, February, and March 2025, from the Perkins County Clerk, Register of Deeds, and Clerk of the District Court.
