The regular meeting of the Board of Commissioners of Perkins County, Nebraska, was held at 8:30 a.m. in the County Courthouse in Grant, Nebraska.

Present: Commissioners Steve Tucker, Darin Robertson, Mark Bottom, Attorney Richard Roberts, and Clerk James Brueggeman.

Chairman Tucker called the meeting to order at 8:30 a.m. It was announced that notice of this meeting had been published in the Grant Tribune-Sentinel on May 1, 2025. Chairman announced the location of the Open Meetings Act Poster in the Commissioner’s Room. Commissioner Bottom made the motion to approve the minutes of April 21, 2025, meeting as published in the Grant Tribune-Sentinel, on Perkins County’s website, and made public in the Clerk’s Office. Public Forum:

Opened at 8:40 a.m. and Closed at 9:25 a.m. No public comment received.

Correspondence:

Commissioners received letters from Grant Community Redevelopment Authority outlining a Tax Increment Financing Project at 204 Hanock Avenue in Grant, from Premier Bank requesting designation as a county funds depository, and an anonymous letter from the family member of a veteran concerning the former Veterans Service Officer.

Unfinished Business:

Commissioners discussed part-time hires for Road Districts 1 and 2. Commissioner Bottom is waiting on filling the District 2 part-time roads position until closer to the time they need to have seasonal help. Commissioner Robertson offered Dennis Steinwart as the part-time hire for District 1. Commissioner Bottom moved to hire Dennis Steinwart part-time in District 1. Commissioner Robertson seconded, roll call vote, 3 ayes, motion carried.

New Business:

Deputy County Assessor Regina Berry met with Commissioners to present and discuss the MIPS Residential Assessment Contract between MIPS and Perkins County. Commissioner Robertson moved to approve and have Commissioners sign the MIPS Residential Assessment Contract. Commissioner Bottom seconded, roll call vote, 3 ayes, motion carried.

Emergency Manager/911 Administrator James Brueggeman discussed with Commissioners renewal of the Nebraska Regional Interoperability Network (NRIN) agreement between NRIN and Perkins County. Commissioner Bottom moved to adopt Resolution 2025-8 renewing the agreement between NRIN and Perkins County. Commissioner Robertson seconded, roll call vote, 3 ayes, motion carried.

Clerk James Brueggeman briefed Commissioners on a proposal from Aflac to provide group dental insurance to county employees at employee expense. Commissioners took no formal action suggesting Aflac poll county employees to gauge interest then return to the board with the proposal if Aflac finds there is interest in their product offering.

Business With Officials:

Sheriff Jeffrey Miller, A-EMT Travis Ogg and County Clerk James Brueggeman provided updates concerning their respective areas of county operations to the Commissioners.

A District Court fee report submitted by District Court Clerk Kathy Woodmancy was acknowledged as received and signed by Chairman Tucker.

Commissioners discussed the hiring of a temporary substitute bus driver for Public Transit during the month of June while two transit employees are scheduled to be out on medical leave.

Commissioners reviewed notice of an upcoming Zoning meeting scheduled for May 12, 2025, at 7:00 p.m.

Chairman Tucker provided Commissioners an update from Highway/Weed Superintendent Steve Leimer who could not be in attendance.

The next regular meeting will be held on Monday, May 19, 2025, 8:30 a.m. at the Perkins County Courthouse in Grant, Nebraska.
